IAFBA SCHOLARSHIP TO SERVING & RETIRED OFFICER/AIRMEN/NCs(E)

VISHESH

(GRANT FOR SPECIAL CHILDREN)

- The aim is to empower Divyang children
 - To make them self reliant.
 - Financially self sustained.
- Monthly maintenance grant @ 3500 /-pm
- For special children with 70% and above disability
- Admissible up to the age of 30 years



GARIMA

(GRANT FOR DIGNIFIED LAST RITES)

- Aim of ensuring decent last rites of the deceased
- An amount of Rs.15,000/- is paid
- Need to approach nearest AF unit for payment of GARIMA
- Grant can be claimed directly from IAFBA



FAMILY ASSISTANCE SCHEME

- Flagship scheme of IAFBA.
- Supports family after death of serving/retired AF personnel.

Monthly rate of Rehab grant payable to Spouse/NoK

Death in Service (for 15 years)	Death after Retirement (for 8 years)
Rs. 8,000/-	Rs. 6,000/-



DAUGHTER'S MARRIAGE GRANT

- To support the marriage of daughter.

<u>Death in Service</u>	<u>Death after Retirement</u>
Rs. 2,00,000/-	Rs. 2,00,000/-

- Minimum 20 years of service is required in case an air warrior dies after retirement.



GRANT FOR PURCHASE OF TRADE INSTRUMENT FOR SELF EMPLOYMENT

- Paid to the spouse of deceased AF personnel to become self employed.
- For purchase of Trade instrument/ laptop.

<u>Death in Service</u>	<u>Death after Retirement</u>
Rs. 50,000/-	Rs. 25,000/-

EDUCATION LOAN



- Loan can be extended beyond retirement upto 5 yrs.
- Max 60 installments.
- Eligible for IT Benefit under Section 80E.
- Option for extension beyond retirement to be intimated 9 months before retirement.
